[Pennsylvania Budget and State Government](#)

- According to State Impact, legislators are examining a possible shale tax to help fund this year's state budget.
- Governor Tom Wolf fired Department of Drug and Alcohol Programs Secretary Gary Tennis. Reportedly, the firing is due to Tennis objecting to Governor Wolf's planned consolidation of the Departments of Human Services, Health, and Drug and Alcohol Programs into a new Department of Health and Human Services.
- Senator Ryan Aument (R-Lancaster) announced his intention to introduce a bill that would mandate a two year budget cycle for Pennsylvania.
- *The Patriot-News* reported that pre-K education advocates plan to seek increased funding in the FY 2017-2018 budget.
- *The Times-Tribune* reported that lawmakers are examining municipal pension reform in addition to state pension reform.
- The Independent Fiscal Office estimates that shale gas impact fees will continue to decrease this year.
- House Speaker Mike Turzai (R-Allegheny) introduced new legislation to increase the available funds for the Educational Improvement Tax Credit and Opportunity Scholarship Tax Credit programs.
- Representative Tony DeLuca (D-Allegheny) announced that he plans to introduce bills that would implement early voting and same-day voter registration in Pennsylvania.

Federal Policy

- President Donald Trump signed an executive order enabling federal agencies to roll back regulations that are part of the Affordable Care Act.
- Senate Majority Leader Mitch McConnell (R-KY) and House Speaker Paul Ryan (R-WI) announced plans to repeal and replace the Affordable Care Act within the next three months. They also announced that tax reform will be at the top of the congressional agenda.
- According to the *Pittsburgh Post-Gazette*, the repeal of the Affordable Care Act will undermine the mental health reforms championed by Representative Tim Murphy (R-PA).
- According to Pennsylvania officials, repealing the Affordable Care Act's Medicaid expansion could leave 675,000 people uninsured.
- The Pennsylvania Budget and Policy Center issued its report on the potential impact of repealing the Affordable Care Act.
- Arts organizations are beginning to organize against potential cuts to federal arts funding.
- House Ways and Means Committee Chair Kevin Brady (R-TX) said that current tax reform discussions are seeking to "unlock more charitable giving."
- According to *The Washington Post*, voting rights advocates expressed concern that President Trump's call for an investigation into alleged voter fraud will lead to restrictive voting laws.
- State Impact reported on President Trump's energy and environmental plans.

Elections 2017 and 2018

- The Associated Press previewed upcoming elections in Pennsylvania.
- Representative Brandon Neuman (D-Washington) announced that he is running to become a judge in the Court of Common Pleas.
- Reverend John Welch kicked off his campaign for mayor of Pittsburgh.

- Uber announced that it is donating transportation services to the Women's Center and Shelter of Greater Pittsburgh.
- Riverview Children's Center announced that it will be expanding its campus.
- *Stanford Social Innovation Review* analyzed the impact of student debt on the nonprofit sector's workforce.

- PublicSource profiled Pittsburgh Mayor Bill Peduto and his plans for leading the city during the Trump Administration.
- Pittsburgh City Council gave preliminary approval to legislation to support Pittsburgh's immigrants.



"The Redevelopment Assistance Capital Program (RACP) is a Commonwealth grant program administered by the Office of the Budget for the acquisition and construction of regional economic, cultural, civic, recreational, and historical improvement projects. RACP projects are authorized in the Redevelopment Assistance section of a Capital Budget Itemization Act, have a regional or multi-jurisdictional impact, and generate substantial increases or maintain current levels of employment, tax revenues, or other measures of economic activity. RACP projects are state-funded projects that cannot obtain primary funding under other state programs. ... The new window for Round 2017/1 will be open for 30 days during the period from January 4, 2017 through February 3, 2017."

"Fired Department of Drug and Alcohol Programs Secretary Gary Tennis said his dismissal from Gov. Tom Wolf's Cabinet stemmed from his opposition to demoting his department to a bureau and consolidating it with apparently two other departments in state government. ... Tennis said he was told it would become a bureau in what was called the Department of Health and Human Services. Currently, the health department is a separate department from human services. Tennis declined to elaborate on the governor's broader consolidation plan."

The projection released Monday by the state Independent Fiscal Office anticipates that the impact fee will bring in \$13 million less than it did last year, continuing the decline trend for the third straight year. Few new wells and older wells that fall below production thresholds are to blame for the drop, the office said."

"House Bill 250 will increase the amount of tax credits available under the Educational Improvement Tax Credit (EITC) program by \$50 million (to \$175 million) and the amount of tax credits available under the Opportunity Scholarship Tax Credit (OSTC) program by \$25 million (to \$75 million) to grow opportunities for parents to make better school choices and help more students escape from failing schools. The two programs open access to good private schools by allowing businesses to claim a tax credit for donations to scholarship funds for low- and middle-income children. More than 40,000 students benefit from the EITC and OSTC programs each year through educational scholarship organizations, which provide scholarships for students to attend non-public schools. Additionally, the program assists countless Pennsylvania students in traditional public schools through the Educational Improvement Organizations portion of the tax credits made available each year, which support innovative educational programs that enhance the regular school curriculum."
